I support the right to bear arms, meaning citizens are allowed to procure, use, and maintain firearms for personal uses. These uses include sport, recreation, and protection. I am a firm believer that with any right comes responsibilities. The Preamble designates the overarching purposes of the Constitution and then specific rights are listed. When we look at the order of the document, I interpret it to mean the responsibilities are outlined first, then the rights are given. When we respect our responsibilities, our rights are not only guaranteed, but many of the arguments about the implementation of those rights can be resolved.
